In Case Nos. 2023AP1030-LV and 2023AP1031-LV, Berrada Properties Management, Inc. and Youssef Berrada (collectively, Berrada) have filed petitions for review of the court of appeals' July 10, 2023 order denying their petitions in each case for leave to file an interlocutory appeal, as well as a subsequent supplemental authority letter. In each of those cases, Berrada has also filed a motion for a stay pending appeal of all proceedings, including discovery, in Milwaukee County Case No. 2021CX11. In Case No. 2023AP1076-W, Berrada has filed a motion for reconsideration of that part of this court's June 26, 2023 order that denied its petition seeking a supervisory writ or an exercise of this court's superintending authority.

In Case Nos. 2023AP1030-LV and 2023AP1031-LV, the State of Wisconsin has filed responses to the petitions for review and the motion for a stay, as well as a response to Berrada's supplemental authority letter. In Case No. 2023AP1076-W, the state has filed a response to the motion for reconsideration. The court having considered all of the filings of the parties,
