No. 2023AP716 Village of Hales Corners v. Singh, L.C.#2022FO828

On August 21, 2023, defendant-appellant-petitioner, Aman Deep Singh, pro se, submitted a petition for review of the court of appeals' July 5, 2023 decision entered in State v. Singh, Case Nos. 2022AP1202-CR, 2022AP1203-CR, and 2022AP1204-CR. The petition for review was inadvertently filed in Village of Hales Corners v. Singh, Case No. 2023AP716. As a result of this inadvertent filing, an order and acknowledgment were issued in Village of Hales Corners v. Singh. On August 22, 2023, Mr. Singh informed this court that his intent was to have his August 21, 2023 petition for review filed in State v. Singh. On August 28, 2023, Mr. Singh filed a "Motion to Enlarge Time" in State v. Singh. In his motion he asks for an extension of time to file a petition for review since his August 21, 2023 petition was inadvertently filed into the wrong case.

Upon consideration of the foregoing,

IT IS ORDERED that the clerk of this court is directed to file the petition for review and all supporting documents received on August 21, 2023 from Aman Deep Singh in State v. Singh, Case Nos. 2022AP1202-CR, 2022AP1203-CR, and 2022AP1204-CR, with a filing date of August 21, 2023; and

IT IS FURTHER ORDERED that the petition for review erroneously filed in Village of Hales Corners v. Singh, Case No. 2023AP716, is hereby dismissed; and

IT IS FURTHER ORDERED that the order and acknowledgement issued in Village of Hales Corners v. Singh, Case No. 2023AP716, in response to the inadvertent filing of the petition for review, are vacated; and

IT IS FURTHER ORDERED that the plaintiff-respondent, State of Wisconsin, shall have 14 days from the issuance of this order either to file a response to the petition for review in State v. Singh, Case Nos. 2022AP1202-CR, 2022AP1203-CR, and 2022AP1204-CR, or to file a statement that no formal response will be submitted; and

IT IS FURTHER ORDERED that the "Motion to Enlarge Time" is dismissed as moot.
