Northern v. Court of Appeals, Dist. III L.C.#2001CF580

The court having considered the motion of petitioner, Lawrence Northern, to vacate the March 19, 2015 order dismissing his petition for supervisory writ for failing to attach a certified copy of his trust fund account statement, and request for leave to commence the matter without being required to prepay the \$195.00 filing fee; and the court noting that petitioner has now filed a certified copy of the trust fund account statement;

IT IS ORDERED that the motion is granted, the March 19, 2015 order is vacated, and the petition for supervisory writ is reinstated.

IT IS FURTHER ORDERED that, in a separate order, this court will determine whether petitioner is entitled to file his petition for supervisory writ without the prepayment of the filing fee. Petitioner is advised that if the court determines that he has assets in trust fund accounts,
