Triplett v. Payne L.C.# 2023AP963

On December 7, 2023, plaintiff-appellant, Deangelo Triplett, pro se, filed a petition to review the court of appeals' November 2, 2023 decision in this matter. The petition was dismissed by order of the same day, as the petition was untimely under Wis. Stat. §§ 808.10 and (Rule) 809.62(1). See First Wisconsin National Bank of Madison v. Nicholaou, 87 Wis. 2d 360, 274 N.W.2d 704 (1979). However, Mr. Triplett's copy of the order, which was mailed to 3397 N. 23rd Street, Milwaukee, WI 53206, was returned to the clerk's office on December 18, 2023.

On December 14, 2023, Mr. Triplett filed a "Petition for Cross-Review." The petition and envelope listed a Chicago, Illinois address for Mr. Triplett. (3722 S. Indiana, Chicago, IL is on the petition and 3772 S. Indiana, Chicago, IL, is on the envelope.) On December 19, 2023, the clerk's office forwarded copies of the court of appeals' November 2, 2023 decision, the court of appeals' December 7, 2023 Remittitur notice, and this court's December 7, 2023 court order to the Chicago, Illinois address. Those documents were returned as undeliverable, unable to be forwarded, on December 26, 2023.

On December 28, 2023, Mr. Triplett sent a letter, via facsimile to the clerk's office, with updated information regarding his new address, which he indicates is 1335 W. Veliet [sic] Street, Milwaukee, WI 53208. On December 29, 2023, the clerk's office forwarded the returned

documents to Mr. Triplett at 1335 W. Vliet Street, Milwaukee, WI 53205. Those documents have not been returned to the clerk. On January 11, 2024, and on January 17, 2024, Mr. Triplett filed copies of a "Brief" and "Appendix."

Because the petition filed December 7, 2023 was dismissed, this court does not have jurisdiction in this matter and will therefore take no action on Mr. Triplett's December 14, 2023 "Petition for Cross-Review," the January 11, 2024 "Brief" and "Appendix," and the January 17, 2024 "Brief" and "Appendix."

IT IS ORDERED that the court will take no action on the documents filed by plaintiff-appellant, Deangelo Triplett.
