Richard A. Lauer v. Dennis Lauer, L.C. #2015PR33

On November 28, 2023, the court of appeals issued its final decision in this matter, and on December 20, 2023, it denied a timely motion for reconsideration filed by appellant-petitioner, Richard A. Lauer, pro se. A petition for review conforming to the requirements of Wis. Stat. § 808.10 and § (Rule) 809.62 must be filed in this court pursuant to Wis. Stat. § 809.80 within 30 days of the court of appeals' adverse decision or within 30 days of the court of appeals' decision on a timely filed motion for reconsideration. See Wis. Stats. § 808.10 and § (Rule) 809.80. Consequently, the deadline for filing a petition for review in this matter was Friday, January 19, 2024. Wis. Stat. § 808.10(1).

In addition, pursuant to Wis. Stat. (Rule) 809.62(2)(f), when a petition for review is filed, an appendix must also be filed "[a]s a separate document" and must contain, among other things, "[t]he decision and opinion of the court of appeals."

On January 19, 2024, appellant-petitioner submitted a single document into the appellate eFiling system which contains both a petition for review and a supporting appendix. The appendix includes a copy of the court of appeals' November 28, 2023 decision, but the decision appears to have been altered from the original.

Therefore,

IT IS ORDERED that, in order to preserve this court's jurisdiction, the combined petition for review and appendix submitted on January 19, 2024, is accepted as filed as of that date; and

IT IS FURTHER ORDERED that, by February 5, 2024, appellant-petitioner shall re-file a corrected petition for review and a corrected appendix as two separate documents. The body of the corrected petition shall not be altered. The corrected appendix shall contain an unaltered version of the court of appeals' November 28, 2023 decision, which can be found at the following link: <https://www.wicourts.gov/ca/opinion/DisplayDocument.pdf?content=pdf&seqNo=733061>; and

IT IS FURTHER ORDERED that the response to the petition for review shall be filed on or before February 16, 2024.
