SCHEDULING ORDER

WHEREAS, a telephone Scheduling Conference was had in the above-captioned matter on 28 June 2006, at 8:45 A.M. Wisconsin time. Appearances were by Dennis J. Flynn, referee, by Attorney Brian Keith Polk appearing for himself and Attorney Julie Falk appearing for the Office of Lawyer Regulation (hereafter OLR), and

WHEREAS, the referee discussed with the parties those issues set forth in Supreme Court Rule 22.15:

NOW THEREFORE, it is hereby ordered as follows:

1. The trial in this matter is scheduled for 6 and 7 September 2006. Proceedings will begin each day at 9:00 A.M.. It is anticipated that the trial will take 1 day and, perhaps, go into a second day. The trial will be held at the Racine County Courthouse. Arrangements for the courtroom and a court reporter will be made by the referee. On 6 September 2006, the assigned courtroom for this trial will be posted on the first floor lobby bulletin board.

2. All Discovery will be completed on or before 10 August 2006.

3. Mr. Polk is appearing Pro Se for this Scheduling Conference. He indicates he will be obtaining counsel. Mr. Polk is to advise opposing counsel and the referee in writing by 17 July 2006, as to the name and address of that counsel. Mr. Polk is also to give that attorney a copy of this Scheduling Order so that s/he can be fully informed as to all scheduling matters in this case.

4. The parties advise that they do not plan to file any motions.

5. Witness lists will be exchanged by the parties as follows:

- A. OLR will provide its Witness List by 17 July 2006.
- B. Atty. Polk will submit his Witness List by 31 July 2006.


6. Exhibit lists will be exchanged by both sides on or before 29 August 2006.

7. The parties may submit trial briefs if they wish. If a trial brief is submitted it is to be provided to opposing counsel and the referee by 29 August 2006.

8. The parties are to make a good-faith effort to reach a written stipulation on facts over which there is no dispute. This should be done in order to reduce the issues to be resolved at the trial as well as the length and cost of that trial. This stipulation is to be filed on or before 9:00 A.M. on 6 September 2006 (when the trial itself begins).

9. The referee notes as a matter of practice in this case that all parties are expected to comply with SCR 62, entitled "Standards of Courtesy and Decorum for the Courts of Wisconsin".
