On February 27, 2024, the court of appeals issued its final decision in this matter. A petition for review conforming to the requirements of Wis. Stat. § 808.10 and § (Rule) 809.62 must be filed in this court within 30 days of the court of appeals' adverse decision. See Wis. Stat. § 808.10. Consequently, the deadline for filing a petition for review in this matter was Thursday, March 28, 2024. Id.

On March 28, 2024, due to an error, a remittitur order was entered prematurely. Also on March 28, 2024, plaintiff-appellant-petitioner, TJ Prop, LLC, filed a petition for review of the court of appeals' February 27, 2024 decision.
