No. 2023AP2084-W      Lanier-Cotton v. Meisner, L.C.#2018CF2604

On January 31, 2024, the court of appeals issued its final decision in this matter, and on February 26, 2024, it denied a timely motion for reconsideration filed by petitioner-petitioner, Jared J. Lanier-Cotton, pro se. A petition for review conforming to the requirements of Wis. Stat. § 808.10 and § (Rule) 809.62 must be filed in this court within 30 days of the court of appeals' adverse decision or within 30 days of the court of appeals' decision on a timely filed motion for reconsideration. See Wis. Stat. § 808.10. Consequently, the deadline for filing a petition for review in this matter was Wednesday, March 27, 2024. Id.

On March 7, 2024, Mr. Lanier-Cotton, pro se, filed a timely petition for review. On March 8, 2024, respondent, Warden Michael Meisner, filed a letter responding to the petition for review. Since the filing of the petition for review and letter response the court has received the following two motions from Mr. Lanier-Cotton: (1) Motion for an extension of time to file indigency forms, dated March 18, 2024, received March 21, 2024; and (2) "Motion for Request to Stay the Petition for Review," dated March 11, 2024, received March 25, 2024. The court notes that on March 27, 2024, Mr. Lanier-Cotton submitted his indigency forms and the court waived his filing fee. The court having considered all of the foregoing,

IT IS ORDERED that the motion for an extension of time to file indigency forms is granted. As noted above, the filing fee was waived by order of March 27, 2024; and

IT IS FURTHER ORDERED that the "Motion for Request to Stay the Petition for Review" shall be construed as a motion to supplement the March 7, 2024 petition for review; and

IT IS FURTHER ORDERED that the motion to supplement is granted. Mr. Lanier-Cotton shall have until May 6, 2024, to file his supplemental petition for review; and

IT IS FURTHER ORDERED that the respondent shall have until 14 days after the filing of the supplemental petition to file a response to the supplemental petition.
