If the petition for review is granted and additional briefs are required, the briefs will be filed pursuant to Rule 809.19(9) and will therefore have the same color covers as the briefs which the parties filed with the Court of Appeals.

The court has requested that parties be notified that the prevailing party on a motion in the Supreme Court, other than a procedural motion, will be awarded \$50.00 costs as attorney's fees unless otherwise directed by the court in its order. Also, please note that the \$195.00 filing fee required under Rule 809.25(2)(a)1, Rules of Appellate Procedure, is not refundable and does not ensure that the petition will be granted.

Because the Court of Appeals may reconsider its decision within 30 days of the filing of a petition for review, we will be furnishing the Court of Appeals with a copy of your petition for review.
