By order of April 18, 2024, this court: (1) granted the motion to extend the time to file a supplemental petition for review, filed by defendant-appellant-petitioner, Tyrone L. Emig, pro se; (2) construed the "partial" petition for review, filed by Attorney James A. Rebholz, as a no-merit petition for review; and (3) ordered Attorney James A. Rebholz to file the no-merit certification required by Wis. Stat. § (Rule) 809.32 (1)(c), within five days of the order (April 23, 2024). The court notes that, to date, Attorney Rebholz has not filed the required certification.

On May 15, 2024, Mr. Emig, pro se, filed a motion for clarification, asking if he is able to file an appendix to his supplemental petition. The court notes that Wis. Stat. § (Rule) 809.32, does not expressly restrict Mr. Emig from filing an appendix. See Wis. Stat. § (Rule) 809.32 Judicial Council committee's note to 1981 amendment.

Upon the foregoing,

IT IS ORDERED that Mr. Emig may file an appendix to his supplemental petition for review. Mr. Emig is reminded that his supplemental petition and appendix are due June 17, 2024; and
