Board of Bar Examiners v. J.S.J.

The Board of Bar Examiners (BBE) has filed a motion pursuant to Supreme Court Rule (SCR) 40.075(7m), asking this court to issue an order requiring Attorney J.S.J. to show cause why his license to practice law in Wisconsin should not be revoked for his willful failure to comply with the conditions set forth in the Consent Agreement for Conditional Admission dated October 31, 2014, together with a motion to seal all filings because they contain confidential information pursuant to SCR 40.12 and SCR 40.075(9).

SCR 40.075(7) provides that a conditionally admitted lawyer's license to practice law is expressly conditioned upon compliance with the terms of the conditional admission agreement. If a conditionally admitted lawyer fails to fulfill the terms of a conditional admission agreement, that failure may result in a modification, extension, or revocation of the agreement or such other action as may be appropriate, including notice to the Office of Lawyer Regulation. *Id.* Upon this court's revocation of a conditional admission agreement, the conditionally admitted lawyer ceases to be licensed to practice law in Wisconsin. Therefore,

IT IS ORDERED that the motion to seal all filings is granted and the matter, including the name of the respondent, Attorney J.S.J., shall remain confidential until further order of the court;

IT IS FURTHER ORDERED that if Attorney J.S.J.'s license to practice law is revoked, the ensuing order will be public, will identify Attorney J.S.J. by name, and will be disclosed to the State Bar of Wisconsin. SCR 40.075(9)(h); and

IT IS FURTHER ORDERED that Attorney J.S.J. show cause, in writing, to this court within 20 days of the date of this order why the BBE's motion should not be granted and his license to practice law in Wisconsin revoked for willful failure to comply with the conditions set forth in the Consent Agreement for Conditional Admission dated October 31, 2014.
