Kaul v. Urmanski, L.C.#2022CV1594

A motion for additional oral argument time having been filed by defendant-respondent, John T. Chisholm, as District Attorney for Milwaukee County; by defendant-respondent, Ismael R. Ozanne, as District Attorney for Dane County; and by intervenors-respondents, Christopher J. Ford, Kristin J. Lyerly, and Jennifer J. McIntosh, and the court noting that the motion indicates that defendant-appellant, Joel Urmanski, as District Attorney for Sheboygan County, does not oppose the motion as long as he is granted the same total argument time as all of the respondents;

IT IS ORDERED that the motion is granted. Oral argument time for the oral argument on November 11, 2024, shall be allocated as follows. D.A. Urmanski shall present argument first and shall be granted a total of 50 minutes of argument time. D.A. Urmanski may reserve up to ten minutes of his argument time for rebuttal.
