**ORDER FOLLOWING SCHEDULING CONFERENCE**

On December 19, 2024, at approximately 10:00 AM, a telephonic scheduling conference was held in this matter, pursuant to SCR 22.15. The Office of Lawyer Regulation appeared by Attorney John T. Payette. Attorney Jonathan V. Goodman appeared on behalf of the Respondent, Joseph P. Bastien.

The parties indicated neither intended to amend their pleadings.

After conferring with the participants:


**IT IS ORDERED:**

1. That discovery and depositions in this matter shall be completed on or before April 18, 2025.
2. Any pre-trial motions shall be filed on or before June 6, 2025. Each such motion shall be accompanied by a supporting brief. Each party shall have until June 16, 2025, to reply to the other party's motion(s).
3. The parties shall disclose to each other the names of witnesses they intend to call at a hearing, along with information necessary for the other to be able to contact any witness listed, and the anticipated evidence to be elicited from each witness, on or before March 21, 2025. If a party later believes it is necessary to call additional witnesses, they shall notify the other and provide contact information by March 28, 2025.
4. The parties shall provide to each other an exhibit list listing all exhibits the party intends to use at the hearing along with a copy of each exhibit that the party intends

to use at the hearing, on or before June 6, 2025. OLR's exhibits shall be numbered beginning with number 1. Respondents shall be numbered beginning with 200.

5. Any Trial briefs shall be filed on or before June 6, 2025.
6. A final pre-trial conference will be held telephonically at 10:00 AM on June 18, 2025, and initiated by OLR. Any pre-trial motions filed by June 6, 2025, will be considered at this conference.
7. A hearing in this matter will be held on June 24 and 25, 2025, commencing at 9:00 AM, at the offices of Quarles & Brady LLP, 411 E. Wisconsin Avenue, Milwaukee, WI 53202. OLR shall arrange for the services of a court reporter at the hearing.
8. All filings shall be made in accordance with SCR 22.13(5).
