After searching for the Court Reporter, I found out from the third person to whom I talk in the Oconto County Clerk of Court that she is Nancy Casper. (920-834-3296)



Thank you for your consideration of this matter.

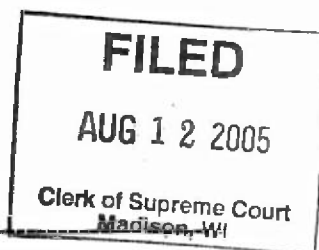
