You are hereby notified that the Court has entered the following order:

No. 2018XX342-BA BBE v. Jason S. Jankowski

On December 3, 2024, this court issued an order reinstating Jason S. Jankowski's license to practice law in Wisconsin, subject to compliance with various conditions. One of the conditions was that "Within 30 days of his reinstatement, Attorney Jankowski shall enter into a contract with WisLAP to participate in its monitoring program for a period of 30 months." Board of Bar Examiners v. Jankowski, 2024 WI 41, ¶15b.

On January 3, 2025, counsel for Attorney Jankowski filed a motion for amendment of this court's December 3, 2024 order to permit Attorney Jankowski to enter into a contract with Recovery Trek to participate in its monitoring program for a period of 30 months. In an affidavit in support of the motion, Attorney Jankowski's counsel states that Attorney Jankowski had been attempting to enroll in a WisLAP monitoring program but had been unsuccessful and had been told that WisLAP would not accept him into any monitoring program.

Attorney Jankowski's counsel states that Recovery Trek has been identified as an appropriate alternate monitoring program for Attorney Jankowski, and Attorney Jankowski has taken preliminary steps to enroll with Recovery Trek and believes that program would provide an

acceptable alternative to the WisLAP monitoring ordered by this court. Counsel for Attorney Jankowski asks this court to amend its December 3, 2024 order to allow Attorney Jankowski to enter into a thirty-month monitoring agreement with Recovery Trek. Counsel states that the Office of Lawyer Regulation does not oppose amending the December 3, 2024 order to provide that monitoring would be done by an entity other than WisLAP. Upon consideration of the foregoing,

IT IS ORDERED that the motion is granted. Attorney Jankowski is directed to proceed with the alternative monitoring by Recovery Trek.
