PLEASE TAKE NOTICE that the Office of Lawyer Regulation (OLR) will move the Supreme Court of Wisconsin's appointed referee for an Order granting default judgment against the Respondent, Amoun Vang Sayaovong (Sayaovong), for Sayaovong's failure to Answer the Complaint in the above-captioned action.

Said motion shall be heard at a date and time set by the referee.

Motion

NOW COMES the Office of Lawyer Regulation (OLR), by Jonathan E. Hendrix, and upon all records, files and proceedings had herein, and upon the *Affidavit of Mailing* of Deborah A. White, *Affidavit of Non-Service* of Patrick Vogl and *Affidavit of Non-Service* of Melissa J. Mata filed on September 17, 2013, the *Affidavit of Non-Service* of Melissa J. Mata filed on October 23, 2013 and the attached *Affidavit of Jonathan E. Hendrix*, moves the Supreme Court of Wisconsin's appointed referee:

1. for a determination that OLR has properly served Sayaovong by certified mail under SCR 22.13(1);
2. for a determination that Sayaovong has defaulted by failing to timely Answer the *Complaint* against him in the above-captioned action;
3. for an Order for Default Judgment, including a determination that all of the allegations of the *Complaint* are deemed established; and

4. for issuance and filing of a report making Findings of Fact and Conclusions of Law consistent with the allegations of the *Complaint*, and including:

- a recommendation to the Wisconsin Supreme Court that Attorney Amoun Vang Sayaovong be publicly reprimanded;
- a recommendation that Attorney Vang Sayaovong be ordered to pay restitution to \$2,000 to Lao Yang; to either promptly submit the Yao Yang matter to binding fee arbitration or pay restitution of \$2,000 to Yao Yang;
- a recommendation that Attorney Vang Sayaovong be ordered to pay the costs of the instant disciplinary proceeding.
