Lorbiecki v. Pabst Brewing Company, L.C.#2018CV4971

On February 27, 2025, a motion was filed on behalf of plaintiff-respondent-cross-appellant, Carol Lorbiecki, seeking relief from the briefing and oral argument schedule due to Ms. Lorbiecki's death. The motion sought an extension for the response brief until March 31, 2025. By order dated February 28, 2025, this court granted the motion, extending the deadline for the plaintiffs-respondents-cross-appellants to file their response brief until March 31, 2025, and removing oral argument from the April 2025 calendar. A second extension motion has been filed on behalf of plaintiffs-respondents-cross-appellants, seeking a further extension of the deadline to file their response brief due to unforeseen issues regarding the administration of the Lorbieckis' estates. The motion states that counsel for the defendant-appellant-cross-respondent-petitioner have no objection to the requested relief. Accordingly,
