Tyler Frick, pro se, currently has five pending matters before this court, listed above. Since April 14, 2025, he has submitted at least 75 different filings in these matters via the e-filing system (not counting filings submitted the date of this order), including over 50 filings in a single day. Many of these filings seek ultimate relief in the underlying circuit court cases. Mr. Frick also seeks to add individuals to his cases, recuse circuit court judges, seal entire case files, compel immediate action by the court of appeals, consolidate certain cases, and withdraw claims for relief previously made. Also, Mr. Frick's most recent filings appear to indicate that he may be attempting to represent another individual before this court, despite not being a licensed attorney. Mr. Frick continuously "supplements" and "corrects" existing filings and demands "acknowledgment" that they have been circulated to chambers. Some of these filings are duplicative and others appear to be in response to routine procedural orders.

The sheer volume and frequency of these filings constitute an abuse of process by Mr. Frick, given the limited resources of this court. This court possesses the inherent authority to curb abusive filing practices, including restricting a litigant's ability to access the court. See Minniecheske v. Griesbach, 161 Wis. 2d 743, 748, 468 N.W.2d 760 (Ct. App. 1991). Therefore,

IT IS ORDERED that Mr. Frick is advised that if he continues his serial filings in the above-referenced matters, this court will impose filing restrictions, which may include: a declaration by the court that the filings in the above-listed cases are now closed; an elimination of Mr. Frick's eligibility to file documents in this court via the e-filing system and a limitation to paper filing; and restrictions on Mr. Frick's ability to represent himself in a pro se capacity before this court.
