Koble Investments v. Marquardt, L.C.#2020SC979

The court having considered the motion of Legal Action of Wisconsin, the University of Wisconsin Law School Economic Justice Institute, End Domestic Abuse Wisconsin, and the Wisconsin Coalition Against Sexual Assault (collectively, the Legal Action amici) for leave to file a non-party brief amicus curiae in excess of the page/word limits for non-party briefs under Wis. Stat. § (Rule) 809.19(7) and (8)(c)3. and for leave to file an appendix containing materials that are not part of the record of this action;

IT IS ORDERED that the motion is granted in part and denied in part. The Legal Action amici may file a non-party brief amicus curiae that shall not exceed 18 pages if a monospaced font is used or 4,000 words if a proportional serif font is used. The non-party brief shall be filed on or before June 9, 2025. The Legal Action amici's request to submit an appendix containing non-record materials is denied.
