The court having considered the motion of defendant-appellant-petitioner, Maries D. Addison, for an extension of time in which to file a petition to review the court of appeals' summary disposition order of May 13, 2025 and for a waiver of the required number of copies of the petition for review;

IT IS ORDERED that the request to extend the time to file a petition for review is denied. The 30-day period in which to file a petition for review may not be enlarged. First Wisconsin National Bank of Madison v. Nicholaou, 87 Wis. 2d 360, 274 N.W.2d 704 (1979).

IT IS FURTHER ORDERED the motion itself shall be deemed to be a timely petition for review. However, a statement in support of the petition, conforming to the requirements of Wis. Stat. §§ 809.62(2) and (4), must be filed with the clerk of this court by July 28, 2025. If the statement is not filed by that time, this petition may be summarily dismissed. The court does not anticipate granting further time extensions.

IT IS FURTHER ORDERED that the request for waiver of the required number of copies is dismissed as moot. Effective July 1, 2023, paper filers in the supreme court are required to submit just a single copy of each filing to the clerk of this court. Wis. Stat. § (Rule) 809.80(1). Consequently, defendant-appellant-petitioner may file one copy of his statement in support of the petition for review on or before July 28, 2025. Further, if the other parties to an appellate proceeding are electronic filing users, as is the case in this matter for the Department of Justice, a paper party is no longer required to serve paper copies upon that party. Wis. Stat. § (Rule) 809.80(2)(c)&(d). Service upon an electronic filing user is accomplished by the clerk of this court entering an image of the filed paper document into the electronic filing system and that system transmitting a notice of docketing or a notice of activity to the electronic filing user. Id.

IT IS FURTHER ORDERED that the clerk of this court shall include a copy of the appropriate fee waiver petition for Mr. Addison's completion with his copy of this order.
