Lorbiecki v. Pabst Brewing Company, L.C.#2018CV4971

This civil action was initiated by plaintiffs Gerald Lorbiecki and Carol Lorbiecki. While the action was pending in the circuit court, Gerald Lorbiecki passed away. Following Gerald Lorbiecki's death, a motion was granted to substitute the Estate of Gerald Lorbiecki as a plaintiff, with Carol Lorbiecki being noted as the personal representative of the Estate of Gerald Lorbiecki. At that point there remained two plaintiffs in the action: (1) the Estate of Gerald Lorbiecki, by Carol Lorbiecki as personal representative; and (2) Carol Lorbiecki, individually. Those two plaintiffs subsequently became respondents and cross-appellants in this appeal.

The court has now received the motion of plaintiffs-respondents-cross-appellants, Estate of Gerald Lorbiecki and Carol Lorbiecki, individually, for the substitution under Wis. Stat. § 803.10 of the Estate of Carol Lorbiecki in place of Carol Lorbiecki, individually, as a plaintiff-respondent-cross-appellant due to her death. The motion notes that Scott Lorbiecki has been appointed as personal representative for both estates. There has been no response in opposition to the motion. Accordingly,

IT IS ORDERED that the motion for substitution is granted. The caption of this matter shall be amended to designate the Estate of Carol Lorbiecki, by Scott Lorbiecki as Personal Representative, and
