No. 2024AP469-CR State v. Rauch Sharak, L.C.#2022CF495

The court having considered the motion of plaintiff-appellant, State of Wisconsin, for leave to file a supplemental, consolidated brief in response to all non-party briefs filed in this case and the companion case State v. Gasper, No. 2023AP2319-CR;
