

On June 20, 2025, pro se petitioner Darin Vaughn Kaquatosh filed a document in this court titled "Original Jurisdiction Procedure in Supreme Court." That filing was given the case number 2025AP1350 and entered as a petition for original action. Because it was unclear exactly what relief Mr. Kaquatosh was seeking and which underlying circuit court case the filing related to, on July 8, 2025, this court entered an order asking Mr. Kaquatosh to clarify whether he was seeking a leave to commence an original action or a writ of mandamus and to specify the underlying circuit court case number. On July 18, 2025, Mr. Kaquatosh responded to that order and indicated that he intended his June 20, 2025 filing to seek a writ of mandamus with respect to Forest County Case No. 23CF89. The clerk of this court inadvertently entered Mr. Kaquatosh's response as a new matter and assigned it Case No. 2025AP1618. Therefore,

IT IS ORDERED that the clerk of this court is directed to file Mr. Kaquatosh's July 18, 2025 response to this court's July 8, 2025 order as an amended petition for writ of mandamus in Case No. 2025AP1350;
