On December 11, 2020, the Honorable Randy R. Koschnick, Director of State Courts, filed this rule petition, asking the court to amend Supreme Court Rule (SCR) 70.19, Wis. Stats. §§ 753.24, 753.26, 757.12, 757.14, 757.70, 807.14, 885.52, 885.54, 885.56, 885.58, 885.60, 967.09, and 971.04 pertaining to the location of court and to the use of videoconferencing technology.

Consistent with standard practice, the court voted to solicit written comments and schedule a public hearing. Letters were sent to interested persons on February 1, 2021. Schmeiser, Wisconsin Association of Criminal Defense Attorneys; Attorney Craig R. Johnson, Sweet and Associates; Attorney Aaron Nelson, Nelson Defense Group; and Chad A. Lanning, Lubar & Lanning.

The court discussed the petition at a series of closed administrative conferences. The court recognizes the convenience and efficiency videoconferencing affords, but is also mindful of the many concerns identified and additional changes proposed by individuals who submitted written statements and offered testimony at the public hearing. Following extensive consideration, the court did not reach consensus on a number of the proposed changes. Accordingly, the court returns the petition to the petitioner, without action.

IT IS ORDERED that this petition is returned to the petitioner.
