#### Issue(s) presented:

1. Did the trial court violate N.A.L.'s due process rights by accepting the stipulation for commitment and issuing an order for involuntary medication without conducting a colloquy to ensure the stipulation was knowing, intelligent, and voluntary?

**Review denied:** The Supreme Court denied review in the following cases. As the state's law-developing court, the Supreme Court exercises its discretion to select for review only those cases that fit certain <u>statutory criteria</u> (see Wis. Stat. § 809.62).
