**Supreme Court case type:** Petition for Review

**Court of Appeals:** District I

**Circuit Court:** Milwaukee County, Judge Kashoua Kristy Yang, *reversed and cause remanded with directions*.

**Issue(s) presented:**

1. Whether federal law preempts the WCA's notice-and-cure provisions, as applied to national banks, because those provisions significantly interfere with a national bank's powers?
