# Wisconsin Supreme Court accepts one case at October 3 conference

Supreme Court case type: Petition for Review

Circuit Court: Outagamie County, Judge Yadira Rein reversed.

**Long caption:** In the matter of the mental commitment of M.J.B.: Outagamie County, Petitioner-Respondent-Petitioner, v. M.J.B., Respondent-Appellant-Respondent.

#### **Issue(s)** presented:

1. Is an examiner's report filed less than 48 hours in advance of the final hearing considered inaccessible under Wis. Stat. § 51.20(10)(b), resulting in the circuit court losing competency to proceed?

**Review denied:** The Supreme Court denied review in the following cases. As the state's law-developing court, the Supreme Court exercises its discretion to select for review only those cases that fit certain <u>statutory criteria</u> (see Wis. Stat. § 809.62).
