How Justice Roggensack's **2012 Proposed Calendar** works.

Justice Roggensack's **2012 Proposed Calendar** for rules petitions would work as follows:

Petition	<b>May 1</b> is last day to file for court consideration at Sept. conference
Post to web	Promptly upon receipt
Chief Justice screening	No date provided
Public comments	June 15 (or <b>45 days</b> after filing/post to web)
Petitioner response	July 15 (or <b>30 days</b> after comment period expires)
Commissioner memo	Sept. 1 (no later than <b>45 days</b> after petitioner's response time)
Court consideration	<b>Sept. 1 - 30</b>
Public hearing	<b>Nov. 14 - 30</b>

**No calendar date(s) set for court decision and approval of orders yet proposed rule cycle includes court decision on the petition. A court decision occurs when an order on the petition is released.**

*The shortest time between petition filing and hearing is 7 months.*

The proposed calendar would produce the following results on filings made June 1 to April 30:
