Re: Reply from Attorney William C. Gleisner, III to Mr. Brown's
February 25, 2014 letter regarding Bar Rule Petitions 13-7 and 13-13

Dear Justices:

Late yesterday afternoon I received an email from Mr. Brown's counsel Attorney Howell (set forth in attached Appendix A), apologizing for not sending me a copy of Mr. Brown's letter which was filed with the Court this past Monday, the 24th of February. Because of misleading statements in Mr. Brown's said letter concerning me, I am compelled to reply.

REPLY CONCERNING THE NOMINATION PROCESS

First, Mr. Brown entirely misses the point. I am not seeking relief because of the nomination process or because of his actions concerning the so-called ballot bio. I cited my experience with both as examples of the State Bar's absence of rules and standards in general. However, since Mr. Brown has made an issue of the nomination process and the ballot bio as they relate to me, I must set the record straight.

The letter which Ms. Marks sent to me back in 2010 did not require that nomination signers print their signatures. In her 2010 letter Ms. Marks stated that "if possible it would be helpful ... if people signing the petition could print their name..." I have included in Appendix B and C the letters of transmittal and copies of the actual nomination petitions (containing 114 signatures) submitted on November 22, 2013 and November 25, 2013. The nomination petition form in the attached was supplied by the State Bar. As can be seen from the attached, the circulator of each nomination petition is printed and clearly identified on a small red index card stabled to left hand corner of each of the said nomination petitions. The red card was not included in the exemplars of my 2013 petitions attached to Mr. Brown's letter (although the stable marks of the card are clearly visible on the pdf copies of my 2013 petitions which he submitted to the Court in Attachment C of his February 24th letter).

Each circulator of each nomination petition in attached Appendix B and C is a licensed member of the State Bar and was required on the face of the nomination petition to provide the following certification: "I certify that I personally know the lawyers who have signed the foregoing nomination petition, and that they maintain their principal offices as shown." There is nothing on the face of the nomination petitions furnished by the State Bar in attached Appendix

B and C, as submitted by me on November 22 and November 25, 2013, or in the rules governing those petitions, that require that the lawyers signing those petitions must print their names next to their signatures.

On November 25, 2013 Mr. Brown disqualified forty-one of the signatures submitted on November 22, 2013 and on November 25, 2013 because of alleged illegibility (without identifying which signatures were objectionable). See Mr. Brown's Attachment B to his letter filed with the Court on February 24, 2014. If I had not known the circulators well, it could have taken some time to satisfy Mr. Brown's new found "requirement" that petition signers had to also print their names. Fortunately, I did know the circulators and they immediately set about providing full identification of who signed each petition. See, e.g., attached Appendix D. By November 27, 2013 at least 100 signatures had been identified according to Mr. Brown's specifications. However, at that point I was not put on the ballot. On December 2, 2013 I submitted another 66 signatures which included a printed identification of each signature See attached Appendix E. I was finally put on the ballot on December 3, 2013.¹ The point I made in my initial February 21, 2014 letter stands; there are no clear rules or standards governing nomination papers.


REPLY CONCERNING THE BALLOT BIO

Far more troubling is Mr. Brown's response concerning the ballot bio. In his letter filed with the Court on the 24th of February, he simply says that I should have followed the example set in 2010-2011. He does not cite any rule or standard regarding what a bio should contain. He does not deny that on two occasions he required that I edit my bio despite assurances that the "State Bar will not edit" a candidate's bio. He also completely ignores the First Amendment implications of his insistence on two occasions that I edit my bio.

CONCLUSION

I respectfully reiterate the points I made in the conclusion to my initial letter regarding the relevance of the foregoing to pending rule petitions 13-7 and 13-13. If we are all required to be members of an integrated State Bar, then that Bar must serve as a neutral arbiter and take care to act transparently and fairly according to clearly enunciated rules so as to serve the interests of all members of the Bar in an equitable manner.


Re: Self-Nomination of William C. Gleisner, III for the Judicial Council


