Re: 17-01, In Re Rule for Recusal When a Party or Lawyer Has Made a Large Campaign Contribution

Dear Chief Justice Roggensack and Justices of the Supreme Court of Wisconsin:

It is important for the reputation of our state courts and for the fair administration of justice that judges aren't deciding cases involving large campaign contributors.

But that is not what the rules governing the courts say in Wisconsin today. And it is why they must change.

Special interests, like the state's corporate lobby, the Wisconsin Manufacturers and Commerce, and other conservative allies, have spent years and huge sums of money helping to secure a conservative majority of judges to the Wisconsin Supreme Court. These same groups then proposed rules to the State Supreme Court to decide when they ought to recuse themselves from cases before them because of conflicts of interest - and when they did not need to do so.

Unbelievably, the conservative majority then approved these rules, literally written by the special interests that supported their elections, to allow judges and justices to participate in cases involving parties that helped their campaigns. Since then, public confidence in the impartiality of the court has declined and many Wisconsinites have questioned the lack of objective criteria requiring recusal under the current rules.

The good news is that the Wisconsin Supreme Court can choose to start to set things right.

Over fifty retired judges from across the state have come together and submitted the petition now before the Court to reconsider rules on recusal. The call is for "... an objective standard requiring recusal or disqualification of a judge when he or she has received the benefit of campaign contributions or assistance from a party or a lawyer ..."

They note how important it is for our courts to be free from corruption, or even the appearance of corruption. Setting objective rules on recusals in cases involving groups or people that spent significant sums to help elect judges sends an important message to Wisconsin regarding our justice system.

Chief Justice Roggensack recently made well publicized comments expressing her concern that trust in the Court and judicial institutions was waning. While questioning the motives of those raising concerns, unacknowledged was how the current conservative court majority has contributed to the environment in which the Court's commitment to fairness and justice is subject to legitimate question, through actions like adoption of the current rule governing recusal and through failure to voluntarily recuse in cases where there is the potential for an appearance of bias or corruption.

The recusal rule petition offers the Court a simple choice:

Accept the petition and begin to restore public faith in the Court and all Wisconsin courts by making a strong statement that our courts can be counted on to fulfill their duty to treat everyone equally under the law and act as a check on overreaches by the legislative and executive branches.

Or reject the petition and defend a status quo where members of this Court and other judges can reap electoral rewards of massive special interest spending with no concern for the appearance, if not the existence, of actual corruption or the damage done to the public's faith in the impartiality of the court.

It is the responsibility and the judgment of the seven members of the Wisconsin State Supreme Court that will decide whether or not the Court can earn back the trust lost as a consequence of the Court's prior actions.

Instead of criticizing "tough talk", it is time for the Court to take real action to set fair rules and restore faith in the judicial branch. The recusal rule proposed by this group of distinguished former judges ought to be adopted.
