MOTION FOR AN EXTENSION TO FILE A REPORT WITH THE COURT


The Board of Bar Examiners (BBE) by and through its legal counsel Jacquelynn B. Rothstein, moves the Supreme Court of Wisconsin for an Order seeking an extension of the deadline to file its report with regard to the issues raised in the above-captioned matter. The BBE requests an extension to September 17, 2018.

By Order dated March 8, 2018, the Court directed the BBE to confer with the Wisconsin Department of Justice and with any other entity it deemed appropriate, and to submit a written report advising the Court whether the Board of Bar Examiners' rules or procedures, including questions on the Board of Bar Examiners' Applicant Questionnaire and Affidavit, should be revised to ensure compliance with the Americans with Disabilities Act.

In response, the BBE convened a subcommittee to consider these issues. Subcommittee members held a preliminary meeting with the Wisconsin Department of Justice in May of 2018, and will again consult with them in July of 2018. Thereafter, the subcommittee will confer with the full Board at its regularly scheduled meeting(s) before issuing its report to the Court. Accordingly, the BBE respectfully requests an extension to file its report to September 17, 2018.
