APPENDIX 12

SCR 22.001 Definitions.

2 In SCR chapter 21 and this chapter:

3 (1) "Attorney" means a person admitted to the practice of law in this state
4 and a person admitted to practice in another jurisdiction who appears before a court
5 or administrative agency in this state or engages in any other activity in this state
6 that constitutes the practice of law.

7 (2) "Cause to proceed" means a reasonable belief based on a review of an
8 investigative report that an attorney has engaged in misconduct that warrants
9 discipline or has a medical incapacity that may be proved by clear, satisfactory and
10 convincing evidence.

11 (3) "Costs" means the compensation and necessary expenses of referees, fees
12 and expenses of counsel for the office of lawyer regulation, a reasonable
13 disbursement for the service of process or other papers, amounts actually paid out
14 for certified copies of records in any public office, postage, telephoning, adverse
15 examinations and depositions and copies, expert witness fees, witness fees and
16 expenses, compensation and reasonable expenses of experts and investigators
17 employed on a contractual basis, and any other costs and fees authorized by
18 chapter 814 of the statutes.

19 (4) "Director" means the director of the office of lawyer regulation provided
20 in SCR 21.03.

21 (5) "Grievance" means an allegation of possible attorney misconduct or
22 medical incapacity received by the office of lawyer regulation.

23 (6) "Grievant" means the person who presents a grievance, except that a
24 judicial officer ~~or a district committee~~ who communicates a matter to the office of
25 lawyer regulation in the course of official duties is not a grievant.

APPENDIX 12A

SCR 22.001 Definitions.

In SCR chapter 21 and this chapter:

(1) "Attorney" means a person admitted to the practice of law in this state and a person admitted to practice in another jurisdiction who appears before a court or administrative agency in this state or engages in any other activity in this state that constitutes the practice of law.

(2) "Cause to proceed" means a reasonable belief based on a review of an investigative report that an attorney has engaged in misconduct that warrants discipline or has a medical incapacity that may be proved by clear, satisfactory and convincing evidence.

(3) "Costs" means the compensation and necessary expenses of referees, fees and expenses of counsel for the office of lawyer regulation, a reasonable disbursement for the service of process or other papers, amounts actually paid out for certified copies of records in any public office, postage, telephoning, adverse examinations and depositions and copies, expert witness fees, witness fees and expenses, compensation and reasonable expenses of experts and investigators employed on a contractual basis, and any other costs and fees authorized by chapter 814 of the statutes.

(4) "Director" means the director of the office of lawyer regulation provided in SCR 21.03.

(5) "Grievance" means an allegation of possible attorney misconduct or medical incapacity received by the office of lawyer regulation.

(6) "Grievant" means the person who presents a grievance, except that a judicial officer who communicates a matter to the office of lawyer regulation in the course of official duties is not a grievant.
